<u>Staff Summary:</u> The Cultural Commission will evaluate and prioritize projects presented by the Department of Arts & Culture that are in fulfillment of the Arts & Culture Master Plan. As presented at the April 14, 2019 Cultural Commission Special Meeting, all Carson City Public Art Programming for FY 19/20 is funded by the projected \$47,647 revenue from the 1% Transient Occupancy Tax. The Commission will allocate up to \$35,647 of these funds for recommended projects in FY 19/20 with the remaining \$12,000 allocated directly by the Arts & Culture Coordinator.

5. FOR POSSIBLE ACTION ITEM

5.A DISCUSSION AND POSSIBLE ACTION TO MAKE RECOMMENDATIONS TO THE REDEVELOPMENT AUTHORITY REGARDING APPLICATIONS REQUESTING FY19/20 REDEVELOPMENT ARTS & CULTURE SPECIAL EVENT FUNDING. STAFF SUMMARY: THE CULTURAL COMMISSION WILL EVALUATE, PRIORITIZE AND MAKE RECOMMENDATIONS TO THE REDEVELOPMENT AUTHORITY REGARDING THE BUDGETED EXPENDITURE OF \$26,315 FOR ARTS & CULTURE SPECIAL EVENT FUNDING FROM THE REDEVELOPMENT REVOLVING FUND FOR FY19/20. A TOTAL AMOUNT OF \$26,315 IS ELIGIBLE FOR

ALLOCATION (\$25,000 ALLOCATED IN FY2019/2020 AND \$1,315 IN UNSPENT ROLLOVER FROM FY2018/2019).

(5:40:57) – Chairperson D'Anneo introduced the item. Mr. Salinas gave background on the allocation eligibility and explained the process by which the funding requests will be presented, scored, and awarded. He also noted that each organization may present their request in maximum three minutes and was allowed a one-minute sample of the event or production. Mr. Salinas clarified that a scoring rubric, put in place last year, will be used to provide the Commissioners' scores once all applicants completed their presentations and after a 10-minute recess. He stated that the scores will range from zero (lowest) to 30 (highest). Mr. Salinas invited the applicants, noting that the presentations will take place based on the order they were received by him, and that their average score will determine the requested percentage allocation. For example, an average score of 15 will result in being awarded 50 percent of the requested amount, and if a commissioner recuses himself or herself, it will not affect the score. He indicated that the applicants were happy with this process last year, adding that the final outcome will result in a recommendation to the Redevelopment Authority for approval during their June 6, 2019 meeting. Mr. Salinas reiterated the three-minute time limit and noted that the applicants will be judged based on the following criteria: artistic merit of the proposed project; clarity of the application; demonstrated community support or investment; audience outreach benefit and/or new audience engagement; intend to develop and evolve the organization; clearly defined ability to successfully complete the project.

(5:51:18) – Deputy District Attorney Ben Johnson requested a short recess to confer with two commissioners regarding disclosures.

(5:54: 51) – Chairperson D'Anneo reconvened the meeting and reintroduced the agenda item. Mr. Johnson invited commissioners with conflicts of interest to make their statements. Commissioner Bugli referenced Nevada Revised Statute (NRS) 281A.420 and disclosed a conflict of interest, stating that she would abstain from voting as she is the president of the Carson City Symphony Association, a grant applicant. Commissioner Bugli recused herself and left the dais.

(5:56:44) – Commissioner Ramirez noted that she would abstain from voting on the Carson City Symphony's request since she is working with the organization to provide guidance on how to increase the Latino community's attendance to the event. Mr. Johnson clarified for Commissioner McBride that quorum will be present due to the scoring methodology.

(5:58:21) – At Mr. Salinas' invitation, seven organizations presented their applications, which are incorporated into the record, and responded to clarifying questions, in the following order:

- Carol Scott, Wild Horse Productions Executive Director: Requested amount: \$4,500, for *Frozen Jr.*, the *Musical*.
- Kathy Bly representing the Brewery Arts Center requested amount: \$5,000 for *Traditional Celtic Music Series*.
- Jeff Basa, Board President, Proscenium Players requested amount: \$3,500 for the 2019-2020 season.
- Elinor Bugli, President, Carson City Symphony Association, Inc. along with Lupe Ramirez, Latino Outreach coordinator requested amount: \$5,000 for *LatinXpressions Four Concert Series*.
- David Bugli, President, Mile High Jazz Band Association, requested amount: \$5,000 Jazz and Beyond.
- Rosine Bena, Artistic Director, Sierra Nevada Ballet requested amount: \$5,000 for *Twelfth Night A Ballet Noir*.

• Molly Walt, President, Pinkerton Ballet Theater – requested amount: \$5,000 for the Nutcracker Ballet.

(7:02:12) – Mr. Salinas requested a five-minute recess to allow the Commissioners time to tally their scores. Chairperson D'Anneo recessed the meeting at 7:02 p.m. and reconvened it at 7:10 p.m.

(7:10:05) – Mr. Salinas explained the scoring process and invited each Commission member to call out their score for each applicant. Chairperson D'Anneo complimented the proposals and commented that the nature of the requests had shifted from the cost of doing business to advertising. Mr. Salinas offered to create an across-the-board survey to make it easier for the groups to execute. He also explained that the request total exceeded the existing funds and recommended making an 11 percent cut across the board (after the weighted scores) to reach the current available fund amount. The final scores and the allocated funds are reflected in the spreadsheet below.

(7:26:24) – Mr. Salinas noted that the next step would be to have the recommendation approved by the Redevelopment Authority during its June 6, 2019 meeting, adding that he will attend the meeting and notify the applicants and the Commission of the outcome. Chairperson D'Anneo entertained public comments.

(7:27:06) – Brewery Arts Center Executive Director Gina Hill clarified that the Brewery Arts Center (BAC) and the Celtic Music Series "are one and the same", adding that the requested funds are for the BAC, but for a specific project "which is exactly how it's laid out in the grant". She noted that surveys had been conducted for each performance for the past four years; however, they were not requested in the grant application. Ms. Hill also wished to understand the reasoning behind the low score of 18, and Commissioner Ramirez responded "I personally feel that we need to make this type of performances more diverse and innovative and I did not see that". Ms. Hill believed that "diverse can come in a lot of different directions. So, this is specific towards one ethnic culture celebration, same as the Hispanic one that Jazz and Beyond is doing for that culture." Chairperson D'Anneo noted that she would like to see "improvement"; "I want to know what changed. How did it get better? Did the audiences increase?" Ms. Hill clarified that Ms. Bly had shown the audience number increasing from 18 to 2,700. Commissioner McBride believed that the final reports received by Mr. Salinas will reflect those changes; however, she wished to see specifics in the application forms next year.

(7:32:04) – Commissioner Bugli returned to the dais. Mr. Salinas suggested hearing final comments from members of the public.

(7:32:17) – Joseph Bly introduced himself and clarified that his degree in theatre lighting technology was a bachelor's and not a master's. He also explained that LED lighting presented around \$17 per-hour savings on energy bills.

Chairperson D'Anneo requested that Mr. Salinas agendize a retreat discussion as well.

ABOUT THE NEA

Initial Public Art Project Becomes a Landmark

Michigan



Hundreds of Grand Rapids residents turned out for the 1969 dedication of La Grande Vitesse, attended by its creator, Alexander Calder. Photo courtesy of the Grand Rapids Public Library

Stamped on everything from the city's letterhead to its garbage trucks, Alexander Calder's La Grande Vitesse is much more than a landmark. It's the ubiquitous symbol of Grand Rapids, Michigan. "Literally and figuratively it's become the heart of the city. It's so fitting that it's bright red," says Nancy Mulnix, who first conceived the project. In 1967, Grand Rapids was building a new city hall downtown in the hopes it would help bring the blighted area back to life. Mulnix asked the fledgling federal arts agency to help the city commission a sculpture for the plaza in front of the new building.

The Arts Endowment awarded a \$45,000 grant to Grand Rapids, as part of the agency's new public art initiative. Mulnix and her committee raised the additional \$83,000 needed to commission, ship and construct the new work. Alexander Calder, one of America's preeminent artists, was chosen to create the first civic sculpture jointly financed by federal and private funds. The NEA went on to fund almost 700 other works as part of its \$15 million public art project. In May 1969, Calder's 42-ton work arrived in Grand Rapids in a series of enormous crates. A huge crane lifted the 27 separate sections so they could be bolted into place. The whole process took five days. "It created a kind of a circus atmosphere," Mulnix remembers. "It was £27 laid out like a jigsaw puzzle. It was fascinating for people to watch this big object grow before their very eyes. The sparks flew as the welders worked and then the vivid color was painted on. It was like outdoor theater."











Guidelines and Application

Grant Summary:

The Carson City Arts & Culture Master Plan states that the Carson City Cultural Commission shall "support(s) multicultural diversity of art, heritage and cultural traditions, which include African-American, Hispanic, Native American, Asian and other ethnic and folk expressions of culture alongside traditional Eurocentric art forms."

A <u>CELEBRATE CULTURE! Grant</u> will educate and enhance multi-cultural vibrancy in Carson City and offer exposure of diverse traditions, histories, and heritage which may encompass: language, art, crafts, architecture, performances, ethnic celebrations, customs, and historical events. Events should be designed to attract the maximum number of people as appropriate for the event and site. Applicants will be responsible for securing the appropriate public exhibition space and any permission or permits required in regards to their proposal.

Celebrate Culture! Grants are based upon availability of annual funds as budgeted by the Department of Arts & Culture. For example:

Fiscal Year 2019/20 budget funds events occurring July 1, 2019 through June 30, 2020* (*Special Rolling Application Process for this year only.)

Fiscal Year 2020/21 budget funds events occurring July 1, 2020 through June 30, 2021 Fiscal Year 2021/22 budget funds events occurring July 1, 2021 through June 30, 2022

Eligibility:

- Applicants may be an Organization or Individual.
- Applicant must hold event(s) within Carson City.
- Event(s) must "support multicultural diversity of art, heritage and cultural traditions, which include African-American, Hispanic, Native American, Asian and other ethnic and folk expressions of culture alongside traditional Eurocentric art forms."
- This grants support exhibitions, productions, events and projects that will be made open and accessible to Carson City residents. The public component can be ticketed or free to attendees.
- Questions about your event's eligibility? Contact Mark Salinas (msalinas@carson.org).

Some Examples of Eligible Projects:

- Play or performance, art production, public reading or presentation.
- Dance performance.
- Music performance or concert.
- Film screening, series or festival.
- Art exhibition, or singular work of visual art work that will be displayed for the public.
- Fashion show, or design that will be displayed in a fashion show.
- Presentation of a masterclass or workshop series for artists.
- Public art works including murals.

Ineligibility:

- Applicants may not apply for both a Redevelopment Arts & Culture Special Event Grant and a CELEBRATE CULTURE! Grant for the same event.
- Applicant is under the age of 18 or a full-time student in a higher education program.
- Projects that serve membership-only organizations or exclude the general public.
- Operating expenses of privately owned facilities, such as homes, studios, and galleries.
- Student scholarships or any re-granting programs. Stipends to Artists are permissible.
- Administrative costs unrelated to the proposed project.
- Fundraisers or charity events.
- Religious institutions.
- Food and drink.

Special Rolling Application Process for Fiscal Year 2019/20 Only*

- All first-time applicants should contact Mark Salinas (<u>msalinas@carson.org</u>) for consultation and introduction to grant process.
- Applicants will submit grant application approximately (10) weeks before event.
- For Fiscal Year 2019/20, the Arts & Culture Coordinator will schedule applicant to present the proposal at a regularly scheduled Cultural Commission meeting (January, March, May, July, September, or November only). At these meetings, the Commission will score grant application and allocate any eligible awards.
- Grant awards are not dispersed at the meeting, or in advance of the proposed event. All awardees are required to submit a W9, invoice, and Final Report within 30 days of the event's conclusion to Mark Salinas for reimbursement. No receipts are required. (msalinas@carson.org).

Standard Application Process

- February: Department of Arts & Culture advertises CELEBRATE CULTURE! grant and availability of funds.
- April: All CELEBRATE CULTURE! grant applications due.
- May: All CELEBRATE CULTURE! applicants present proposals to the Cultural Commission for scoring and possible funding.
- July 1: Funded events commence.
- June 30: Funded events conclude.
- Grant awards are not dispersed at the May meeting, or in advance of the proposed event. All awardees are required to submit a W9, invoice, and Final Report within 30 days of the event's conclusion to Mark Salinas for reimbursement. No receipts are required. (msalinas@carson.org).

Scoring Criteria:

At the May presentation, each Cultural Commissioner will individually score grant proposals 0 - 5 points in six categories for a total of 30 possible points. Commissioners will then discuss allocations based upon scoring and available funding. Cultural Commissioners must be recused from presentation, discussion, and voting of any application with which he/she is associated directly or indirectly.

0 = None, 1 = Poor, 2 = Marginal, 3 = Good, 4 = Excellent, 5 = Outstanding

- Artistic quality of the proposed project (0 to 5 points)
 Does applicant seek to advance artistic excellence within a cultural diversity that is under represented?
- Clarity of narrative and budget (0 to 5 points)

 Does applicant's proposal evoke a clear project understanding within obtainable funding measures?
- Defined ability to successfully complete the project (0 to 5 points)
 Does applicant have the reputability, resources, staffing, or history to accomplish set proposal?
- Community investment in the project proposal (0 to 5 points)
 Does the proposal have other community support or collaboration (sponsorship, funding, in-kind donations) which will elevate an audience experience?
- Community-at-Large development (0 to 5 points)
 Does proposal achieve new growth or new awareness for Carson City's cultural pluralism?
- Carson City Arts & Culture development (0 to 5 points)
 Does the proposal include new or innovative outreach methods for publicity, exposure, education, and awareness for the project?

Guidelines:

- Any unspent grant awards from the Commission are surrendered and do not roll forward into next fiscal year for awardees.
- The Cultural Commission, at its discretion, may roll surrendered, unspent, and/or unallocated funds into other CELEBRATE CULTURE! events, or apply those monies elsewhere in the Department of Arts & Culture's Public Arts Programming budget.
- Grantees must utilize this credit line in any media and press release: "This event is funded in part by a CELEBRATE CULTURE! Grant from the Carson City Cultural Commission." A Cultural Commission logo will be provided to the applicant.

Final Report:

Submit final report within 30 days of event completion. The Final Report must be submitted and approved before possible funding for the next fiscal year. The Municipality of Carson City reserves the right to use any materials submitted in the final report for any public usage for educational, promotional, or tourism-based purposes.
